

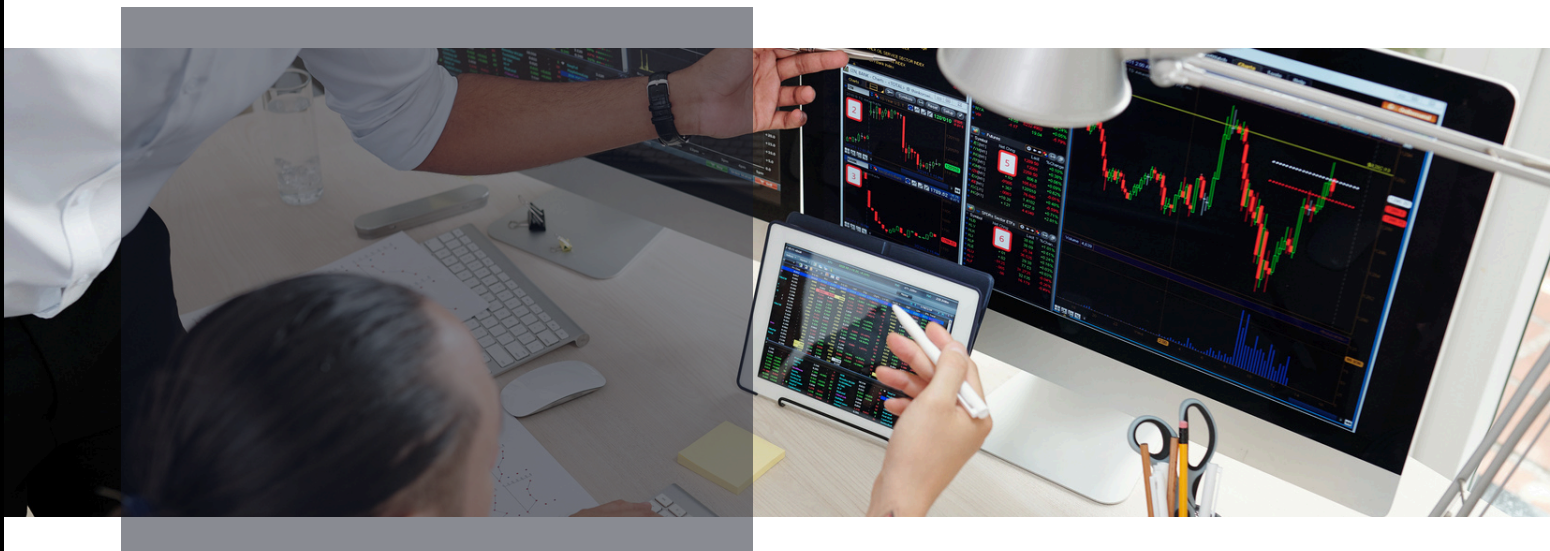


# INDEX TRADING TACTICS
